Business Development Services

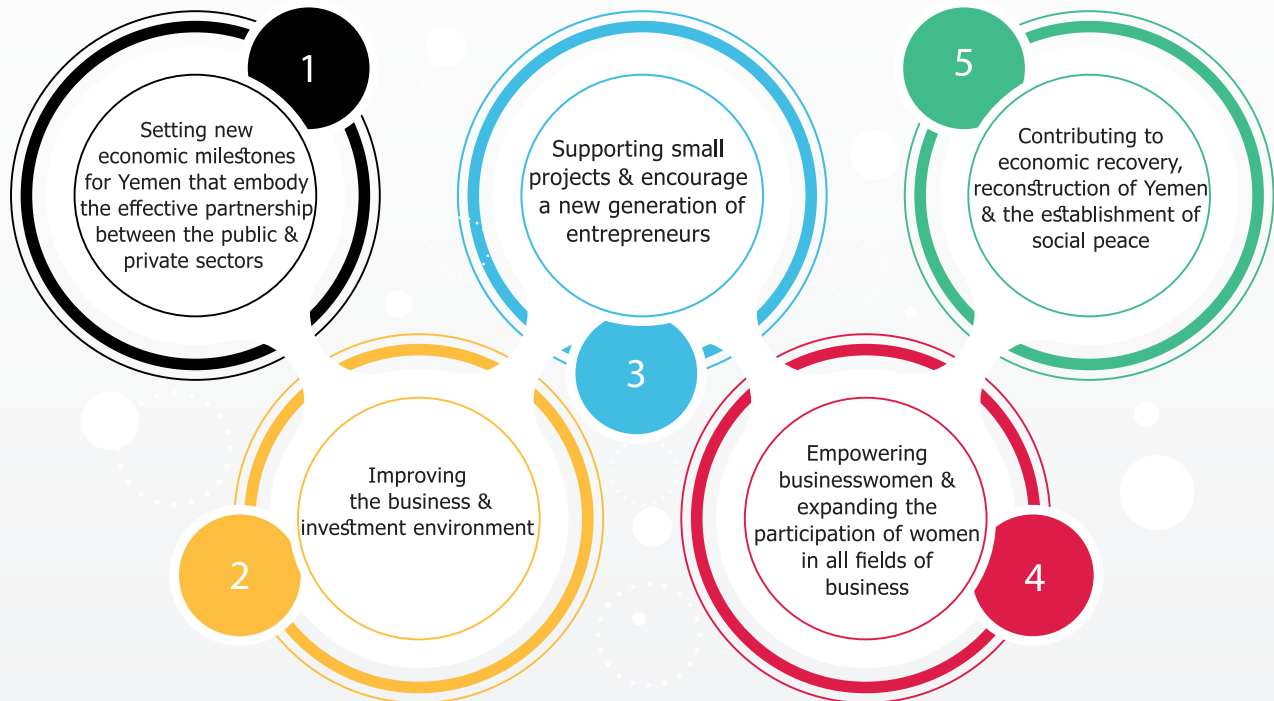
We provided advisory services, technical and legal support & make sure that local entrepreneurs take part in national & local investment projects.

The Goals of the Federation

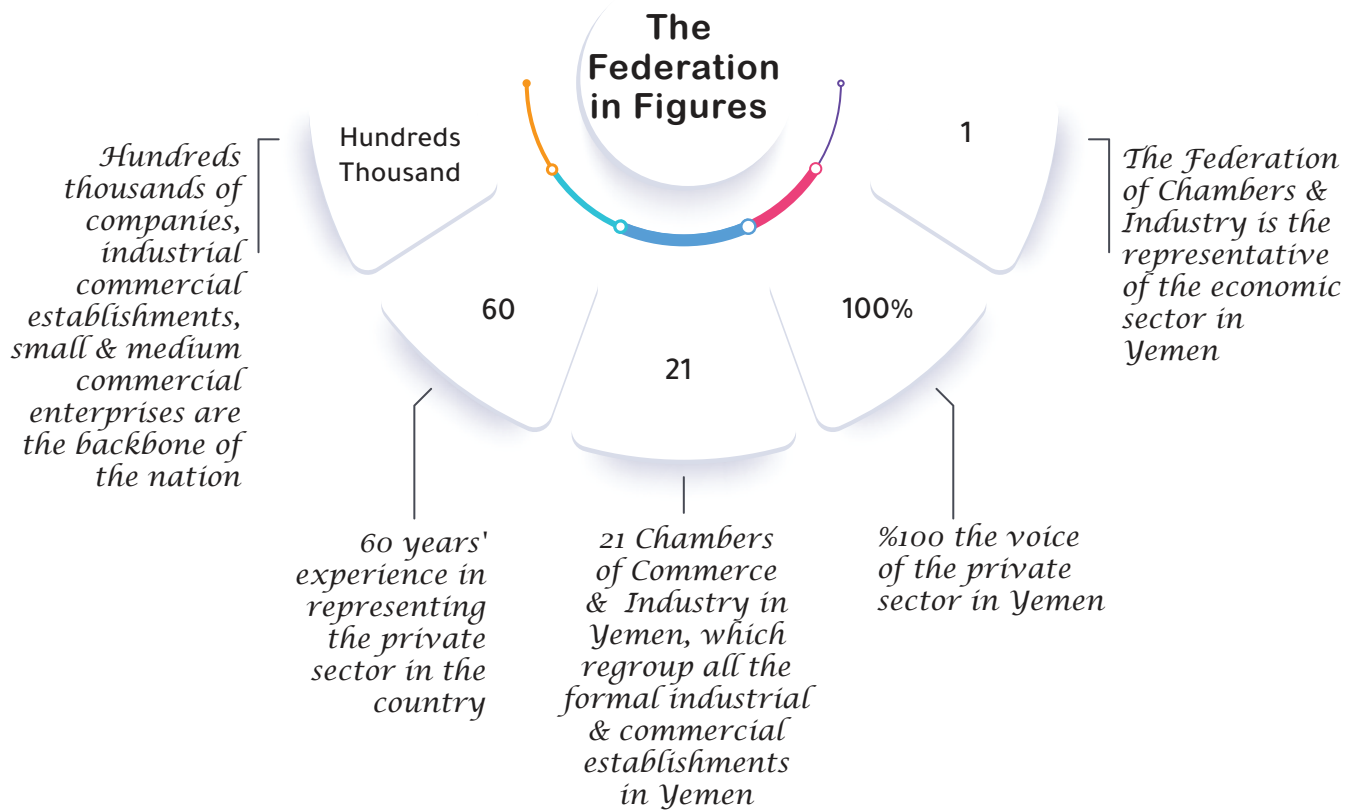
The Federation has strategic goals to bring about a comprehensive development renaissance in Yemen, in which the private sector has a key role.
